

ORDINANCE NO. 2417

AN ORDINANCE OF THE CITY OF ERLANGER, IN KENTON COUNTY, KENTUCKY, AMENDING ORDINANCES 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 IN REGARD TO BUDGETS FOR THE CITY OF ERLANGER FOR THE FISCAL YEARS BEGINNING ON THE FIRST DAY OF JULY IN 2007, 2008, 2009, 2010, 2011, 2012, 2013 and 2014, RESPECTIVELY.

WHEREAS, Ordinances 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 of the City of Erlanger were for the purpose of adopting budgets for the fiscal years beginning on the first day of July in 2007, 2008, 2009, 2010, 2011, 2012, 2013 and 2014, respectively; and

WHEREAS, there was inadvertently omitted from each of those ordinances the enacting clause required by KRS 83A.060(2); and

WHEREAS, the omission of the enacting clause required by KRS 83A.060(2) in each of the ordinances numbered 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 has caused some concern that the effect of those omissions is to invalidate those ordinances, even though each of those ordinances and the budgets adopted thereby were respectively amended by ordinances 2300, 2322, 2347, 2354, 2364, 2380, 2396, and 2406, each of which included the enacting clause required by KRS 83A.060(2); and

WHEREAS, the purpose of this ordinance is to amend ordinances each of the ordinances 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 to include the enacting clause required by KRS 83A.060(2); and thereby refute the concern about the validity of those ordinances as a consequence of the omission of the enacting clause;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF ERLANGER, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

Section 1.0 – Ordinance Amendments:

1.1 Each of the Erlanger ordinances numbered 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 are hereby amended to add to each of them the enacting clause required by KRS 83A.060(2), all in conformity with the language in the attachments A through H to this ordinance, which are hereby incorporated herein by reference, with the text being added indicated by a single line drawn underneath it, as required by KRS 83A.060(3).

1.2 Each of these respective amendments to Erlanger ordinances numbered 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 shall be retroactively applied to the respective dates of the enactment of each of them.

1.3 The amendment by this ordinance of each of the Erlanger ordinances numbered 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 has no effect on the budgets adopted thereby; and each of those budgets shall still be subject to the respective amendments of them by ordinances 2300, 2322, 2347, 2354, 2364, 2380 and 2396 and 2406.

1.4 All contracts and disbursements pursuant to each of the Erlanger ordinances numbered 2285, 2301, 2323, 2348, 2355, 2365, 2381 and 2397 prior to the amendment thereof by this ordinance are hereby approved and ratified.

Section 2.0 – Provisions Severable:

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect as long as they remain valid in the absence of those provisions determined to be invalid.

Section 3.0 – Conflicting Ordinances Repealed:

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

Section 4.0 – Effective Date:

This ordinance shall be effective as soon as possible according to law.

Section 5.0 – Publication:

This ordinance shall be published in summary pursuant to K.R.S. 83A.060(9).
